2. The time for the members to vote by poll was fixed one hour by the Chairman of the Meeting and the polling paper were circulated by us to all the members at their email ID

3. The polling papers received within the stipulated time from the members over the scrutinizer's email were considered for determining the result.
4. The polling papers were subsequently opened infront of two witnesses on Sept 26, 2025 and all polling papers were diligently scrutinized. The polling papers were reconciled with the records maintained by the Registrar and Transfer Agents of the Company, M/s KFin Technologies Limited and the authorizations / proxies, if any lodged with the Company.

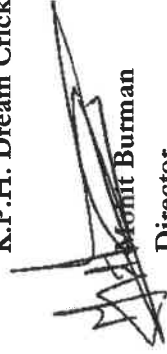
